Premier:

- 6. Mr D B Haddon to ask the Premier:
 - (1) Whether her Office hired any vehicles using Government funds from 1 January 2012 up to and including the latest specified date for which information is available; if so, what was the (a) make and (b) model of each specified vehicle hired;
 - (2) (a) how many kilometres were travelled by each specified vehicle and (b) what was the cost of hiring each vehicle;
 - (3) (a) what were the (i) reasons for and (ii) details in respect of of each specified trip undertaken by these vehicles and (b) why were departmental vehicles not used to undertake these trips?

- 7. Mr P E van Vuuren to ask the MEC responsible for Public Works, Roads and Transport:
 - (a) Why has the service-provider Master Blinds, which delivered and installed blinds for the Department of Social Development and Special Programmes, not received any payment for this work, (b) who is to be held responsible for the delay in payment and (c) when will this payment be made?

- (3) whether approximately 110 ambulances are being kept in East London for distribution; if so, (a) when will these vehicles be distributed and (b) how many of these vehicles will be allocated to each specified depot;
- (4) (a) how many ambulances were servicing the Kouga and Koukamma regions as at the latest specified date for which information is available, (b) how many of these vehicles are still roadworthy and (c) what is the mileage of each vehicle;
