#### 110. Mr N Bhanga to ask the Premier:

Noting that government officials were reportedly found to be doing business with the state;

- (1) Whether he can kindly furnish (a) how many officials, per department, has his Office found to be doing business with the state, (b) what products / services were rendered by each official, (c) what is the position of each official and (d) the (aa) details pertaining to the contract entered into by the official and the state and (bb) amount paid in invoices for the aforementioned contracts;
- (2) whether he, either as Premier or in his former role as MEC, has commissioned an investigation into the government officials who were found to be doing business with the state; if so, can he kindly provide the outcomes of the investigation; if not, why;
- (3) whether the (a) Heads of Departments (HODs) and (b) Accounting Officers have taken any remedial steps towards those subordinates found to be doing business with the state; if so, what action; if not,
- (4) what consequence management has his Office taken in this regard;

(5) whether his Office has taken any steps with a view to refining the registration of companies on databases in order to flag companies that are associated with the state; if so, can he kindly provide the relevant details in this regard; if not, why?

#### 111. Mr N Bhanga to ask the Premier:

Whether he can kindly indicate (a) which departments currently rent office space, (b) where the office space is situated, (c) how much the monthly rental costs are and (d) who the lessor is in each case?

### 112. Mr N Bhanga to ask the MEC responsible for Cooperative Governance and Traditional Affairs:

- (1) How much (a) total debt is owed to each municipality in the province and (b) of that debt has his Department written off as bad debt for the (i) 2017/18, (ii) 2018/19 and (iii) 2019/20 financial years as at the latest specified date for which information is available;
- of the aforementioned debt, how much (a) is the total debt incurred and (b) has his Department written off as bad debt for the following unpaid services (aa) water, (bb) sanitation, (cc) electricity, (dd) refuse removal and (ee) property rates for the financial years specified above as at the latest specified date for which information is available;
- (3) what current control systems have the municipalities put in place with a view to ensuring effective municipal billing;
- (4) can he kindly provide reasons for the non-payment of services by residents;
- (5) what steps has his Department put in place with a view to ensuring the payment of these critical services in future?

### 113. Ms V Knoetze to ask the MEC responsible for Cooperative Governance and Traditional Affairs:

Noting the alleged exorbitant rates increase in Buffalo City Metropolitan Municipality (BCMM) for the current financial year:

Whether he can kindly provide a comparative breakdown of (a) water, (b) electricity and (c) property rate increases for (aa) residential, (bb) commercial and (cc) industrial users for the (i) 2017/18, (ii) 2018/19 and (iii) 2019/20 financial years as at the latest specified date for which information is available?

### 114. Ms V Knoetze to ask the MEC responsible for Cooperative Governance and Traditional Affairs:

Noting the alleged vandalism of the Mzamomhle water treatment plant control room at Burgersdorp in Walter Sisulu Municipality:

- (1) Whether he has been informed of the situation of alleged cable theft and general vandalism at the control room which has reportedly left the water treatment plant non-operational; if not, what is the position in this regard; if so, what action has his Department taken in this regard;
- (2) whether his Department has opened a case of vandalism with the South African Police Service (SAPS); if not, why; if so, what is the case number;
- due to the water treatment plant being reportedly non-operational, where is the sewage being treated?

## 115. Mr R Odendaal to ask the MEC responsible for Cooperative Governance and Traditional Affairs:

- (1) Whether the Inxuba Yethemba Municipality approached his Department for concurrence in the appointment of their (a) Municipal Manager, (name furnished for the purpose of the reply) and (b) Chief Financial Officer (CFO), (name furnished for the purpose of the reply; if not, can he kindly provide the relevant details in this regard; if so, whether his Department has given concurrence; if not,
- (2) whether his Department is satisfied that the aforementioned individuals have the minimum competencies to be appointed as municipal manager and CFO respectively within this municipality; if not, can he kindly provide the relevant details in this regard?

## 116. Mr Y Cassim to ask the MEC responsible for Economic Development, Environmental Affairs and Tourism:

- (1) Whether he has been informed that Kei Mouth caravan Park, which has reportedly been a source of income and tourism for many years, is allegedly in need of infrastructure maintenance; if not, what is the position in this regard; if so,
- (2) as a tourist attraction, how many visitors visited the caravan park in the (i) 2016/17, (ii) 2017/18 and (iii) 2018/19 financial years as at the latest specified date for which information is available;
- (3) can he kindly provide details as to how was total income generated by the caravan park in the aforementioned financial years as at the latest specified date for which information is available;
- (4) what intervention has his Department implemented with a view to assisting in rectifying the infrastructure issues at the caravan park;
- (5) who is responsible for the infrastructure maintenance of the caravan park;
- (6) whether his Department deems it possible for a local committee, namely Kei Mouth Revival Project (KMRP) to be mandated and contracted to manage the aforementioned caravan park; if so, who can be approached with this proposal, can he kindly provide a name in this regard?

#### 117. Mr Y Cassim to ask the MEC responsible for Education:

- (1) Whether he has been informed of the alleged irregular appointment of administration clerk of Upper Tabase Junior Secondary School by officials in the Mthatha District; if not, what is the position in this regard; if so,
- (2) whether his Department has conducted any investigation in this regard; if so, what were the findings of the investigation;
- (3) whether his Department has found the outcome of the investigation to be irregular; if so, can he kindly provide the relevant details in this regard;
- (4) whether his Department has found any officials to have been involved in the irregular appointment; if so, can he kindly supply the (a) position of the official(s) involved and (b) actions taken by the official(s) that deemed the process irregular;
- (5) whether his Department, on conclusion of the investigation, has found any department officials guilty; if so, what consequence management has his Department implemented with a view to holding the officials accountable;

- (6) whether his Department has found that the principal's signature was forged on certain documents pertaining to the appointment of the candidate; if so (a) who forged the signature and (b) what consequence management has his Department implemented against the person responsible;
- (7) whether the appointed candidate submitted their resume before or after the shortlisting process; if submitted after the shortlisting process, (a) why was the candidate's application considered, (b) who granted permission for the candidate's application to be considered after the shortlisting process was reportedly completed and (c) what consequence management has his Department implemented against the person who granted permission;
- (8) how many appointments (a) has his Department found to be irregular in the (i) 2016, (ii) 2017, (iii) 2018 and (iv) 2019 academic years as at the latest specified date for which information is available and (b) are currently being investigated, can he kindly indicate in what year was each case of investigation initiated;

#### 118. Mr Y Cassim to ask the MEC responsible for Education:

- (1) Whether he has been informed that there are still mud schools that are reported to be operational in the province; if not, what is the position in this regard; if so,
- (2) how many mud schools are still operational in the province;
- (3) when his Department anticipates all mud schools will be eradicated in the province;
- (4) what role does his Department play in the eradication of mud schools in the province;

- (5) what total cost his Department envisages is needed in order to eradicate all mud schools in the province;
- (6) can he kindly supply a list of all operational mud schools in the province indicating the (a) name of the school, (b) location of the school and (c) number of learners who attend the school;
- (7) subsequent to a response received to Question 8 of IQP 7, containing Questions for Oral Reply, dated Friday, 6 April 2018, (a) what is the progress of the 69 mud schools that were allocated to the province to be dealt with through the conditional grant, (b) how many schools has his Department completed and (c) how many are still incomplete;
- (8) can he kindly provide the current status of each project, including the (a) amount allocated to for each project, (b) amount still available to complete the project, (c) date of completion, (d) implementing agent and (v) reasons for incomplete projects;
- (9) what steps has his Department implemented with a view to ensuring that the projects are completed?

#### 119. Mr R Odendaal to ask the MEC responsible for Finance:

- (1) Whether his Department is satisfied that all (a) departments and (b) provincial entities in the provincial administration have implemented cost cutting measures / implementation of austerity measures as per National Treasury's 2019 Medium Term Expenditure Framework (MTEF) Technical Guidelines; if not; can he kindly provide the relevant details in this regard; if so,
- (2) whether the actual savings made by such cost cutting measures / implementation of austerity measures in (a) departments and (b) provincial entities are measured by Treasury; if not, why; if so,
- (3) can he kindly provide details, with a descriptive schedule, of all savings made in this regard by comparing these expenditure line items in the 2018/19 financial year with that incurred for the 2017/18 financial year as at the latest specified date for which information is available?

#### 120. Mr R Odendaal to ask the MEC responsible for Finance:

- (1) What is the total wage bill/cost of employment for each of the provincial entities for the (i) 2016/17, (ii)2017/18 and (iii) 2018/19 financial years as at the latest specified date for which information is available;
- (2) what is the average increase in the total wage bill/cost of employment for each of the provincial entities for the aforementioned financial years as at the latest specified date for which information is available;
- (3) what is the total cost of employment for each of the respective (a) Chief Executive Officers (CEOs) and (b) Chief Financial Officers (CFOs) of the provincial entities for the aforementioned financial years as at the latest specified date for which information is available;
- (4) what is the total cost of employment for all directors/executive managers of the respective provincial entities for the aforementioned financial years as at the latest specified date for which information is available?

#### 121. Ms J Cowley to ask the MEC responsible for Health:

Noting that the Sister B. Francis Clinic and the Sister L. Sookdin Clinic in the Nelson Mandela Bay Metropolitan Municipality (NMBMM) reportedly currently have no stock of the anti- depressant medications called Citalopram and Fluoxetine:

- (1) Whether she has been informed that these two clinics are alleged to be currently out of stock of the abovementioned medicines; if not, what is the position in this regard; if so,
- (2) (a) why do the clinics mentioned above allegedly not have these medicines in stock and (b) when her Department anticipates the aforementioned medicines will be in stock;
- (3) what measures, if any, has her Department put in place with a view to ensuring that in the event of a stock-out of these products, there will be other anti-depressant medication available;
- (4) what steps her Department envisages it will take with a view to ensuring that the clinics mentioned above, and all other clinics, have a constant supply of anti- depressant medication, as the consequences of not taking this medication can be dire?

#### 122. Ms J Cowley to ask the MEC responsible for Health:

Noting that Tuberculosis (TB) is still the major contributor to mortality in the province:

- (1) What is the total number of (a) tuberculosis (TB) and (b) Multi Drug Resistant (MDR) TB patients treated in the last financial year as at the latest specified date for which information is available, can she kindly provide the response per quarter and per district, including for the first quarter of the current financial year (2019/20);
- (2) (a) what is total number of (aa) TB patients and (bb) MDR TB who have defaulted on medication in the last financial year as at the latest specified date for which information is available, can she kindly provide the response per quarter and per district, including for the first quarter of the financial year specified above and (b) of the defaulters mentioned above, what (i) were the reasons for defaulting and (ii) is the number of mortalities?

#### 123. Ms J Cowley to ask the MEC responsible for Health:

Noting that the Raymond Mhlaba Clinic in Riebeeck East in Makana Municipality has an alleged high incidence of asthma patients:

- (1) How many patients has her Department treated for asthma, per quarter and per district in the last financial year as at the latest specified date for which information is available;
- (2) as an average per district, how many patients that visit clinics are treated for asthma;
- on average, how many patients visit the abovementioned clinic per annum;
- (4) what percentage of the patients in 3 above are treated for asthma?

#### 124. Mr S Magaqa to ask the MEC responsible for Human Settlements:

Noting a case of an individual (name and details furnished for the purpose of the reply) who allegedly resides in ward 35 of Buffalo City Metropolitan Municipality (BCMM) in Izinyoka Village, also noting that, as per the alleged confirmation of the then Director: Destitute and other Vulnerable Groups of Human Settlements, (name furnished for the purpose of the reply) in September 2017 that the beneficiary's application for an RDP house had been approved on the 381 Project in BCMM and

finally noting that the beneficiary has reportedly been prioritized and that her house would be built as soon as a contractor is on site:

- (1) Why has the beneficiary mentioned above allegedly not been allocated an RDP house on the 381 Project, as allegedly confirmed by her Department to date whilst other beneficiaries have reportedly been allocated houses;
- what (a) process has her Department followed in allocating houses to other beneficiaries and leaving the aforementioned beneficiary without a house and (b) role has the ward councillor played in the allocation of houses in the project;
- (3) whether she has been informed that there is an allegation of manipulation and tampering of the beneficiary list by the ward councillor; if not, what is the position in this regard;
- (4) when her Department anticipates the abovementioned beneficiary will be allocated an RDP house, as per the alleged confirmation by her Department;
- (5) whether her Department has completed and handed over any units to beneficiaries in the project; if so, how many; if not, can she kindly provide the reasons for non-completion;
- (6) what is the cost of the completed units;
- (7) who is the contractor that her Department has appointed in the project?

#### 125. Mr S Magaga to ask the MEC responsible for Human Settlements:

With reference to the Herald newspaper article entitled "Soweto on Sea in a grave state" dated Monday, 22 July 2019:

- (1) Whether she has been informed that there are houses allegedly built around and on top of grave sites in the aforementioned area Soweto on Sea in Nelson Mandela Bay Metropolitan Municipality (NMBMM); if not, what is the position in this regard;
- (2) whether her Department has any plans in place with a view to relocating the beneficiaries of the houses in order to identify and mark all the graves in the area; if not, (a) why and (b) by when her Department anticipates this matter will be resolved;

- (3) who is the contractor that allegedly built the houses in the aforementioned area;
- (4) whether the aforementioned contractor is still building houses in the province; if so, (a) where were the houses built since 1994 and (b) what is the total cost of projects that the said contractor built since 1994;
- (5) whether her Department has blacklisted the said contractor since he is alleged to have built houses with shoddy workmanship; if not, (a) why and (b) when her Department anticipates the contractor will be backlisted;
- (6) whether she has been informed of the reasons as to why was the Zanemvula Project halted, which was reportedly meant to deal with housing challenges in the aforementioned area; if not, what is the position in this regard; if so,
- (7) whether her Department has any plans in place with a view to resuscitating the project; if so, when can the beneficiaries expect the project to resume?

#### 126. Mr S Magaqa to ask the MEC responsible for Human Settlements:

- (1) What is the total number of title deeds issued by her Department in the last financial year as at the latest specified date for which information is available and can she kindly provide the list per quarter;
- (2) whether she has received representations with regard to reports of a backlog in transferring and delivering title deeds to beneficiaries in the province; if not, what is the position in this regard; if so,
- (3) (a) can she kindly provide reasons for such backlog and (b) what is the backlog for the last financial year as at the latest specified date for which information is available;
- (4) whether her Department has put any plans in place with a view to dealing with the backlog; if not, why; if so, can she kindly provide the relevant details in this regard;
- (5) (a) what is her Department's target for transferring deeds to beneficiaries in the current financial year, (b) in which districts and (c) what plans has her Department put in place with a view to meeting the said targets?

#### 127. Ms V Knoetze to ask the MEC responsible for Public Works:

Noting the alleged closure of the iconic Nelson Mandela Museum in Qunu since February 2017 due to infrastructure decay and poor workmanship:

- (1) What is the name of the contractor that his Deaprtment has awarded the renovation contract for the aforementioned museum;
- (2) what steps has his Department put in place with a view to ensuring that the allocated R30 million for renovations will be spent in line with required standards;
- (3) what is the proposed completion date of the renovations to the structure?

### 128. Ms N Zibonda to ask the MEC responsible for Rural Development and Agrarian Reform:

Noting the utterances by the Premier on cannabis and it being a possible investment:

- (1) Whether her Department has conducted any formal study on the pronouncement above and its potential economic benefits; if not, why; if so, can she kindly provide the relevant details in this regard;
- (2) (a) how many people are employed in the agricultural sector in the province and (b) whether there has been an increase or decrease in the number; if so, what has been the cause of the increase or decrease;
- (3) (a) how much her Department anticipates the province will be investing in this project and (b) why;
- (4) whether her Department has looked into how the crop will create opportunities for employment in the province; if not, why; if so, can she kindly provide the relevant details in this regard;
- (5) whether her Department has considered a policy framework (a) for the legalisation and (b) to curb unintended consequences; if not, why; if so, can she kindly provide the relevant details in this regard?

#### 129. Mr R S Stevenson to ask the MEC responsible for Safety and Liaison:

With reference to the alleged robbery at the Middledrift police station:

- (1) How many police officers were actually on duty the night the police station was reportedly robbed and can she kindly provide the relevant details in this regard;
- (2) how many police officers, on average, are meant to be on duty at the aforementioned police station, per night and can she kindly provide the relevant details in this regard;
- (3) whether there is currently a shortage of police officers at the police station mentioned above; if so, how many officers are (a) still needed and (b) there currently and can she kindly provide the relevant details in this regard;
- (4) by when her Department anticipates these vacancies will be filled;
- (5) whether her Department has put any contingency plans in place in police stations in order to prevent a similar ordeal from occurring; if not, why; if so, what is the current strategy in place;
- (6) in respect to (5) above, how was it possible for the Middledrift police station to be robbed;
- (7) what plans has her Department put in place with a view to ensuring that no other police station in the province experiences the same ordeal;
- (8) whether the aforementioned police station has ever been through a similar ordeal in the past; if so, can she kindly provide the relevant details as to (a) when did it occur, (b) what was stolen and (c) what measures has her Department put in place with a view to ensuring that the incident is not repeated;
- (9) what firearms were stolen from the police station and can she kindly provide the relevant details in this regard?

#### 130. Mr R S Stevenson to ask the MEC responsible for Safety and Liaison:

- (1) Which institutions of higher learning are plagued by alcohol and drug abuse and can he kindly provide the relevant details in this regard;
- (2) whether her Department is monitoring the institutions of higher learning with regard to the possible abuse of alcohol and drugs; if so, what are the names of the institutions that her Department (a) is currently monitoring and (b) intends on monitoring for the 2019/20 financial year as at the latest specified date for which information is available:

- (3) with respect to the institutions that her Department is monitoring, whether her Department has found any evidence that there is abuse of alcohol and drugs at these institutions; if so, what is the nature of the abuse;
- (4) whether her Department has determined if there is a relationship between crime and alcohol abuse at these institutions that they are monitoring; if so, what (a) are the crimes that have been committed in respect of each institution that it is monitoring and (b) steps is her Department taking with a view to dealing with the issues of drug and alcohol abuse at the institutions in relation to crime?

#### 131. Mr R S Stevenson to ask the MEC responsible for Safety and Liaison:

- (1) How many police stations have been (a) attacked or (b) robbed in the province in the (i) 2018/19 and (ii) 2019/20 financial years as at the latest specified date for which information is available;
- (2) how many people were (a) killed or (b) injured in these attacks in respect of each police station in the province in the financial years mentioned above as at the latest specified date for which information is available and can she kindly provide the relevant details in this regard;
- (3) what steps are the police stations taking with a view to improving security;
- (4) in relation to the attacks and robberies at these police stations, whether any firearms were taken; if so, how many firearms (a) were taken and (b) have been recovered in the (i) 2017/18, (ii) 2018/19 and (iii) 2019/20 financial years as at the latest specified date for which information is available and can she kindly provide the relevant details in this regard?

#### 132. Mr P E van Vuuren to ask the MEC responsible for Social Development:

- (1) Whether she has been informed of Bhukuqweni Pre-school, Non-Profit Organisation (NPO) number 180-323, registration date 4 November 2016, in Port St Johns; if not, what is the position in this regard; if so,
- (2) whether her Department has received any funding applications from the abovementioned pre-school; if so, in which years were the applications received;

- (3) whether her Department approved the application; if so, what subsidy amount did her Department provide to the pre-school and for which financial years; if not,
- (4) can she kindly provide the reasons as why was the application not successful;
- (5) how many Early Childhood Development (ECD) funding applications has her Department (a) received and (b) approved for the (i) 2016/17, (ii) 2017/18 and (iii) 2018/19 financial years, per district, as at the latest specified date for which information is available;
- (6) how many children (a) should attend and (b) currently attend ECD centres in the province, per district, as at the latest specified date for which information is available?

#### 133. Mr P E van Vuuren to ask the MEC responsible for Social Development:

- (1) Whether she has been informed of any anti-gender violence shelters in the province; if not, what is the position in this regard; if so,
- (2) how many shelters are in the province (a) in total and (b) per district;
- (3) how many individuals can each shelter accommodate;
- (4) what is the monthly expenditure of each shelter;
- (5) what is the monthly funding from her Department to each shelter;
- (6) what is the state of the (a) security, (b) sanitation facilities, (c) infrastructure and (d) disability access of each shelter?

#### 134. Mr P E van Vuuren to ask the MEC responsible for Social Development:

- (1) How many people live with HIV/AIDS in the province, per district;
- (2) how many (a) government facilities and (b) Non-Profit Organisations (NPOs), run by her Department, service people living with HIV/AIDS, per district, in the province and (c) can she kindly provide their names;
- (3) what is the total amount of funding has her Department given to each (a) government facility and (b) NPO with regard to (1) above;

(4) whether these NPOs have received their subsidy on time for the current and previous financial years as at the latest specified date for which information is available?

### 135. Ms N Zibonda to ask the MEC responsible for Sport, Recreation, Arts and Culture:

- (1) Whether she has been informed of the 11.4 million that was allegedly given to the Mbhashe Municipality for the construction of a stadium; if not, what is the position in this regard; if so,
- (2) whether the funds have been used for their intended purpose; if not, what have the funds been used for and can she kindly provide the relevant details in this regard;
- (3) what (a) is the current status of the stadium and (b) has been the cause of the alleged delay in its completion;
- (4) whether there is a shortage of funds for completing the construction of the stadium; if so, what (a) measures has her Department put in place with a view to sourcing funds and (b) total cost is needed to complete the project;
- (5) who (a) administered the funds and (b) was mandated to oversee the project;
- (6) how many other projects of this nature have been (a) abandoned and /or (b) completed in the (i) 2016/17 (ii) 2017/18 and (iii) 2018/19 financial years as at the latest specified date for which information is available?

- (2) (a) what is the total number of learners who qualified for scholar transport for the above specified academic year as at the latest specified date for which information is available and (b) how many of the abovementioned learners her Department anticipates will be receiving the required transport;
- (3) what is the total number of learners, in the province, who require scholar transport as at the latest specified date for which information is available;
- (4) whether her Department has any plans in place with a view to providing additional transport to qualifying learners; if so, can she kindly (a) provide the relevant details in this regard and (b) specify how much has her Deaprtment budgeted in this regard?

#### 139. Mr M von Buchenroder to ask the MEC responsible for Transport:

- (3) whether her Department has put any plans in place for additional routes in the 2019/20 financial year; if so, can she kindly provide the names and details of the routes;
- (4) what is the budget for (a) scholar transport and (b) scholar transport operators for the aforementioned financial years as at the latest specified date for which information is available;
- (5) (a) how many scholar transport operators are there in the province for the current financial year as at the latest specified date for which information is available and (b) what rate is paid per operator;
- (6) what repercussions has her Department intended for transport operators who fail to comply with the requirements for scholar transport operators as specified in the scholar transport policy;
- (7) (a) how many transport operators has her Department found to be in violation of the abovementioned requirements, (b) what punitive measures has her Department taken for each transport operator, and can she kindly provide response per district, per school and (c) can she kindly specify what stipulations were violated;
- (8) what monitoring measures has her Department instituted with a view to ensuring that transport operators adhere to the requirements set out in the scholar transport policy?
