RESPONSE TO QUESTION 1

2018/2019 – 48 Incidents of farm attacks reported 2019/2020 to date – 09

(2) whether her Department has noted any upsurge in incidences of farm attacks; if so, can she kindly provide the relevant details in this regard;

RESPONSE TO QUESTION 2

An increase of nine (9) cases has been recorded for the 2018/2019 financial year as compared to the 2017/2018 financial year, where a total of 39 incidents were reported.

(3) how many people were (a) killed, (b) injured and (c) raped during these attacks for the abovementioned financial years as at the latest specified date for which information is available;

- (4) what steps is the South African Police Service (SAPS) taking with a view to promoting rural safety and security;

RESPONSE TO QUESTION 4

The Rural Safety Strategy has been implemented at all stations that are categorized as rural and rural/urban mix stations to enhance policing in the rural and farming communities.

Activation plans have been developed in order to deal with any incidents that occur to ensure a quick response and follow up on any incidents of attacks. Stations are tasked to intensify their visibility within the rural communities to ensure the communities feel and are safe.

Visiting of farms has been intensified and during these visits, farmers are sensitized on their safety.

The implementation and roll out of the Traditional Policing Strategy in the Kingdoms of the rural areas which is supporting and enhancing the Rural Safety Strategy.
